Total Marks = 100 out of which

Rest of 30 Marks will be taken from the Mid-Term Examination.

Total Marks = 100 out of which

Practical Experiment will carry 20 Marks

Spotting will carry 30 Marks (10 Nos. each carrying 3 Marks)

Viva will carry 40 Marks (20 Marks each for Internal and External Examiner)

Practical Record Book will carry 10 Marks

Scheme of Examination for Master of Physiotherapy

Theory

Total Marks = 100

Practical

One long Case (1 No.) = 40 Marks

Short Case (2 Nos \times 20 marks) = 40 Marks

Viva = 20 Marks (10 Marks each for Internal and External respectively)

It is mandatory to submit dissertation to the SSUHS to be eligible for appearing in the final (4th Semester) examination. The thesis shall be adjudicated by one external examiner.

N: B: 1. It may be noted that minimum 75% attendance in theory and 80% in practical is mandatory for the students to be eligible to appear in the semester examinations.

2. All the students from each course have to secure 40% Marks in each of the subjects separately for both Practical and Theory in order to pass the Semester Examination.

3. Students who fail in either Theory or Practical Examination shall have to appear only in the respective theory or practical examination where he/she has failed, in the Supplementary Examination.
