**(Masters of Hospital Management under SSUHS)**

**Applications in plain paper** with supporting testimonials are invited from the eligible graduates in MBBS/ BDS / B.Sc. Nursing from any recognized University for admission into Masters of Hospital Management course under the, Srimanta Sankaradeva University of Health Sciences. The candidates will have to appear in the interview on **21-03-2025** at the office of the University. All admission shall be strictly on the basis of marks secured in the qualifying examination (MBBS/ BDS / B.Sc. Nursing final examination), and marks obtained in interview. The marks of qualifying examination and interview will have 50% weightage each in preparation of merit list.

**Details of the course is as follows:**

1. Name of the Course : Masters of Hospital Management (MHM)
2. No. of Seat : 30 (thirty) [10 seats reserved for in-service candidates]
3. Application Fees : Rs.2000/- (Rupees two thousand) only payable online through University website only
4. Session Start Date : Date of commencement of class will be notified in due course of time
5. Duration of the course : 2 years (four semester) inclusive of Internship & Dissertation
6. Course Fees : Rs.65,000/- (Rupees sixty five thousand) only per semester
7. Registration & Exam fees : As per rates of PG courses
8. Stipend : There shall be no provision of stipends for the students.

In-service candidates are required to submit NOC from their parent institutions/ employer at the time of interview.
